- 2. If customerserviceinquiry form is populated and TXTYP not = E, then return error: FTRTXTYP002 VALID TXTYP FOR CUSTOMERSERVICEINQUIRY FORM IS E
- 3. If TXTYP is not populated then, return error: FTRTXTYP003 TXTYP IS REQUIRED
- 4. If TXTYP is populated and vv = B and TXACT does not = E, U, X then, return error FTRTXTYP004 INVALID TXACT FOR TXTYP = B
- 5. If TXACT is not populated, then return error: FTRTXTYP005 TXACT IS REQUIRED.
- 6. If populated and TXTYP = G and TXACT not = A, K, M, U, then return error: FTRTXTYP007 INVALID TXACT FOR TXACT G
